NOTICE OF REFERENDUM SCHOOL DISTRICT OF JEFFERSON NOVEMBER 5, 2024

Referendum Election Details

At an election to be held in the School District of Jefferson on November 5, 2024, the following proposed Revenue Limit Resolution of the School Board will be submitted to a vote of the people:

RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET TO EXCEED REVENUE LIMIT BY \$1,400,000 PER YEAR FOR FOUR YEARS FOR NON-RECURRING PURPOSES

BE IT RESOLVED by the School Board of the School District of Jefferson, Jefferson County, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,400,000 for the 2024-2025 school year and for each of the succeeding three school years thereafter, for non-recurring purposes to fund operating costs to maintain educational and co-curricular programs, including elementary reading; behavioral and mental health resources for students; school safety and technology infrastructure; and to sustain student to staff ratios.

Ballot Text

The question will appear on the ballot as follows:

"Shall the School District of Jefferson, Jefferson County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,400,000 for the 2024-2025 school year and for each of the succeeding three school years thereafter, for non-recurring purposes to fund operating costs to maintain educational and co-curricular programs, including elementary reading; behavioral and mental health resources for students; school safety and technology infrastructure; and to sustain student to staff ratios?"

Explanation

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election question as set forth above.

A "yes" vote on the question is a vote to authorize the School District of Jefferson budget to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,400,000 for the 2024-2025 school year and for each of the succeeding three school years thereafter, for non-recurring purposes to fund operating costs to maintain educational and co-curricular programs, including elementary reading; behavioral and mental health resources for students; school safety and technology infrastructure; and to sustain student to staff ratios.

A "no" vote on the question is a vote to deny the School District of Jefferson the authority to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,400,000 for the 2024-2025 school year and for each of the succeeding three school years thereafter, for non-recurring purposes to fund operating costs to maintain educational and co-curricular programs, including elementary reading; behavioral and mental health resources for students; school safety and technology infrastructure; and to sustain student to staff ratios.

In the event a majority of the electors voting on the question vote "yes", the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,400,000 for the 2024-2025 school year and for each of the succeeding three school years thereafter, for non-recurring purposes to fund operating costs to maintain educational and co-curricular programs, including elementary reading; behavioral and mental health resources for students; school safety and technology infrastructure; and to sustain student to staff ratios; if a majority vote "no" on the question set forth above, the District will not be so authorized.

Location and Hours of Polling Places

Information as to the location of the polling places is available in the District Office at 206 South Taft Avenue, Jefferson, Wisconsin.

All polling places will be open at 7:00 A.M. and will close at 8:00 P.M. All polling places are accessible to elderly and disabled voters.¹
